Part 1

Trailers

 $\S 101$. Definitions. The following words when used in this Part 1 shall have the meanings respectively ascribed to them in this $\S 101$ except in those instances where the context clearly indicates a different meaning:

PERSON - includes any person or persons, firm or corporation.

TRAILER - any structure which is mounted, or designed for mounting, upon wheels and which includes accommodations designed for sleeping or living purposes for one or more persons, excepting a device used exclusively upon sanitary rails or tracks.

VEHICLE - every device mounted, or designed for mounting on wheels in, upon or by which any person or property is or may be transported or drawn upon a public highway.

- §102. Vehicles or Trailers not to be Used as Living Quarters. From and after the effective date of this Part 1, no person shall, within the limits of the Borough of Coplay, occupy, reside in or use as living quarters any vehicle or trailer. (Ord. 284, 7/10/1951, \$2)
- §103. Unlawful to Lease or Permit Use of Vehicles or Trailers as Living Quarters. From and after the effective date of this Part 1, no person, whether as owner or agent, shall lease to or permit the use of by a person any vehicle or trailer as living quarters within the limits of the Borough of Coplay. (Ord. 284, 7/10/1951, §3)
- $\S104$. Establishment of Trailer Parks or Trailer Camps Unlawful. From and after the effective date of this Part 1, no trailer park or camp, designed or intended for the purpose of supplying a location or accommodations for trailers, shall be established or erected within the limits of the Borough of Coplay. $(Ord.\ 284,\ 7/10/1951,\ \S4)$
- §105. Penalty for Violation. Any person or persons, firm or corporation who shall violate a provision of this Part 1 or fail to comply therewith, or with any of the requirements thereof, shall be subject to a fine not more than six hundred (\$600.00) dollars and costs, or in default of payment thereof, shall be subject to imprisonment for a term not toe exceed thirty (30) days. Each day that a violation of this Part 1 continues shall consititute a separate offense. (Ord. 284, 7/10/1951, §5; as amended by Ord. 623, 2/13/1990).
