Pres. Bodish led pledge of allegiance:

Hearing of person: Rick Hess requesting possible change of Rec & Welfare Tree lighting ceremony due to years of dwindling attendance from a Thursday evening after Thanksgiving to a Saturday afternoon in December. Annie Kileen questioned the Police Department's staffing.

PWD Boyle: UGI paving tomorrow and Thursday, Chestnut Street from 11th to Ruch Street a final pave, mill to overlay curb to curb. Basketball court to be paved tomorrow, strip and mount back boards to be finished next week. Last Thursday Acela walked 11th Street, looking at issues of handicap ramps. Once we have plans, they go to the county, then able to put out to bid. Mid-to late August starts. Moving forward with Multi modal, streets involved in that grant being surveyed. UGI back on Magna Drive doing laterals lines. Halfway point of street sweeping in town, in addition, suction end working well in emptying storm drains. Mr. Kern inquired about the missing flag on cell tower.

BCO Helman: no report

Chief Emerich reported: For month of June collected \$360. 00; including one vendor fee. 23 traffic arrests, 8 written warnings, 27 borough tickets. 218 incidents with 4 arrests. Which Includes retail thief and dui, domestic assault, reckless endangerment. Solicitor permit issued year to date is 2: Moxi Pest control and Turf Pro Lawn Care. Multiple reports of people knocking on doors; citizens are encouraged to call police if solicitor doesn't have permit. Citizens are to confirm who is at their door and not to be drawn out of home.
